**Eligibility Criteria-**

1. Citizenship: The Applicant must be a citizen of India.
2. Age- Not less than 17 years as on 31st December in the year of application.
3. The candidate must be a domicile of West Bengal.
4. The candidates must qualify in the West Bengal Joint Entrance Examination for Engineering/ Technology (WBJEE) conducted by WBJEEB.
5. The candidate must pass Higher Secondary (10+2) Examination of the West Bengal Council of Higher Secondary Education or its equivalent examination in science stream from any recognized Board/ Council from any institution within West Bengal.
6. The candidate must pass the Higher Secondary (10+2) or its equivalent examinations with Physics, Chemistry, Mathematics and English as compulsory subjects with individual pass marks (in both theory and practical wherever applicable) in all the above four subjects in regular class mode.
7. The candidate must obtain at least 50 % marks (40 % in case of candidates belonging to SC, ST, OBC-A, OBC-B, PwD) in above four subjects taken together.

  - iii. Domicile Certificate as per the Govt. of West Bengal Notification issued from time to time in this regard.
  - iv. Reservation Category Certificate (wherever applicable).
  - v. WBJEE -2020 Rank Card.
4. Declaration on ragging must be given along with the application form in prescribed format at the time of admission.

After publication of Provisional Merit List on 25.01.2021, the valid and interested rank holders may participate in the counseling process by registering themselves online through University website ([www.wbuafsc.org](http://www.wbuafsc.org)) as per the date(s) notified for the purpose. **Candidates must have to register themselves online to participate in the said counselling cum admission process.** Online Application/ Registration does not ensure a candidate got admission and the decision of the admission committee is full and final.
