Candidates will have to bring the following testimonials along with originals for verification at the time of physical reporting and admission failing which the candidate will not be considered for admission:

- Printed hardcopy of online filled in Application Form,
- Rank Card of NEET-UG-2025 conducted by NTA,
- Admit Card of NEET-UG-2025 conducted by NTA,
- Original Medical Fitness Certificate issued by any registered Medical Practitioner,
- Self attested photocopy of Secondary Examination Admit Card/ Birth Certificate as age proof,
- Self attested photocopy of Mark sheet of Secondary Examination,
- Self attested photocopy of Mark sheet of Higher Secondary (10+2) Examination,
- Self-attested photocopy of SC/ST/OBC (Category-A)/ OBC (Category-B) Certificate (wherever applicable),
- Valid NCL Certificate for OBC (Category-A)/ OBC (Category-B) candidates (wherever applicable),
- Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b) as per guidelines of Govt. of West Bengal. (Click here to download the proforma). Domicile Certificate obtained from the West Bengal e-district portal (https://edistrict.wb.gov.in/PACE) will also be accepted as the proof of domicile.
- Declaration on curbing the menace of ragging (<u>Click here</u> to download the proforma).

The Admission fee of **Rs. 10,770/-\* (Day scholar)** and **17,870/-\* (Hosteller)** for General, SC, ST, OBC (Category-A) & OBC (Category-B) candidates have to be deposited on the day of admission **by cash through Bank-challan of Union Bank of India, Belgachia branch** located at **University Campus**.

The venue for 2<sup>nd</sup> Counselling, Physical Reporting and Admission will be at the Examination hall under the Office of the Controller of Examinations, WBUAFS, Vivek Bhawan, 68, K. B. Sarani, Belgachia, Kolkata – 700 037, West Bengal (Nearest location- Belgachia Metro Station, Google map location- Click here to locate).

Only candidates are eligible to enter into the Counselling venue for Physical Reporting and Admission on presenting the "Printed hardcopy of Online Filled-in Application Form" (Click here to download). Entry starts at 11.00 A.M. and ends at 11.45 A.M. Names of the candidates will be announced during counselling and they must be very careful as it will be announced once only. Candidates reporting after 11:45 A.M. will not be entertained.

## **General Instructions:-**

- 1. The Provisional Merit List has been made as per NEET-UG-2025 Rank.
- 2. The Provisional Seat Allotment will be made serially from the Final Merit list till filling up of the available seats from the respective categories.
- 3. All the admission will be provisional. At any stage if it is found that you are otherwise ineligible or you have suppressed any material information or you have submitted false information/ documents, the admission will stand cancelled.
- 4. The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an updated NCL certificate on the day of physical reporting, counselling and admission failing which the candidate will be treated as Unreserved (UR). NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.
- 5. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056- BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106- BCW/MR38/2025 and 1107- BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
- 6. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (Category-A) candidates if unfilled, will be filled up by the OBC (Category-B) candidates and vice versa.
- 7. Candidate must have to produce Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b or edistrict) issued by the competent authority only as per guidelines of Govt. of West Bengal (Click here to download the proforma) on the day of the counselling and admission failing which the candidate will not be considered for admission. In case of proforma b or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhaar Card, Passport) of the concerned parent during the stage of document verification where the said ID cards show that the residential address is in West Bengal. Domicile certificates issued by any elected people's representative such as municipal commissioner, Councilor of Municipal Corporation/Municipality, Member of three-tier Panchayat system or GTA, MLA or MP are not acceptable.
- 8. Participation in counselling does not constitute a right for admission and the decision of the admission committee is full and final. Candidates who fail to attend Counselling on the notified date and time shall forfeit their claim for admission and participation in further rounds of Counselling (if any).
- 9. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
- 10. The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
- 11. University may cancel or withheld the admission process in unavoidable circumstances.
- 12. The selected candidates must have to submit the downloaded online Anti-Ragging affidavit, it is mandatory for every student and his/her parents to submit an anti-ragging affidavit at the time of first registration and there after each year at the time of subsequent registration through two designated websites, namely <a href="https://www.antiragging.in">www.antiragging.in</a> and <a href="https://www.antiragging.in">www.antiragging.in</a> antiragging.
