Eligibility Criteria-

1. Citizenship: The Applicant must be a citizen of India.
2. Age- Not less than 17 years as on 31.12.2025.
3. The candidate must be a domicile of West Bengal.
4. The candidate must pass Higher Secondary (10+2) Examination of the West Bengal Council of Higher Secondary Education or its equivalent examination in science stream from any recognized Board/ Council from any institution.
5. The candidate must pass the Higher Secondary (10+2) or its equivalent examinations with Physics, Chemistry, Biology and English as compulsory subjects with individual pass marks (in both theory and practical wherever applicable) in all the above four subjects in regular class mode.
6. The candidate must obtain at least 50 % marks (40 % in case of candidates belonging to SC, ST, OBC-A, OBC-B, PwD) in above four subjects taken together.
7. The selection of students for admission will be done as per merit list without any Entrance Examination. The merit list will be prepared according to percentage of total marks obtained in the subjects of H.S. or its equivalent examinations as stated above.

General Instructions:-

1. Applicant can make the payment of online application fee (**Non-refundable**) [Rs. 1500/-* for General/OBC (CATEGORY-A)/OBC (CATEGORY-B)/EWS and Rs. 1200/-* for Reserved Categories (SC/ST/PwD)] by Online Payment (Net-banking/ Debit card/ Credit card/UPI). [*Service charges and applicable taxes, if any are extra].

2. Candidates must also upload following scanned copies (**colour**) of their original documents in **JPG/JPEG** format. Application will not be accepted unless required documents are uploaded.
- Admit card of Secondary Examinations /Birth certificate for verification of date of birth.
 - Mark sheet of Secondary (Class X) Examinations.
 - Mark sheet of Higher Secondary (10+2) Examinations.
 - Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b) as per guidelines of Govt. of West Bengal. ([Click here](#) to download the Proforma). Domicile Certificate obtained from the West Bengal e-district portal (<https://edistrict.wb.gov.in/PACE>) will also be accepted as the proof of domicile.
 - SC/ST/OBC(CATEGORY-A)/OBC(CATEGORY-B)/EWS/PwD Certificate (wherever applicable)
 - Latest NCL Certificate for OBC (Category-A)/ OBC (Category-B) candidates (wherever applicable)
 - Aadhaar Card.
3. Reservation of University seats as per Govt. of West Bengal rules.
4. **Candidate must have to produce Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b or e-district) issued by the competent authority only as per guidelines of Govt. of West Bengal ([Click here](#) to download the proforma) along with the online application as well as on the day of the physical reporting, counselling and admission failing which the candidate will not be considered for admission.** In case of proforma b or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhaar Card, Passport) of the concerned parent during the stage of document verification where the said ID cards show that the residential address is in West Bengal. **Domicile certificates issued by any elected people's representative such as municipal commissioner, Councilor of Municipal Corporation/ Municipality, Member of three-tier Panchayat system or GTA, MLA or MP are not acceptable.**
5. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (CATEGORY-A) candidates if unfilled, will be filled up by the OBC (CATEGORY-B) candidates and vice versa.
6. **The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(CATEGORY-B) candidates must produce an updated NCL certificate on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(CATEGORY-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.**
7. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056- BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107- BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
8. The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
9. Only submission of online application does not constitute a right for admission and the decision of the admission committee is full and final.
10. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
11. University may cancel or withheld the admission process in unavoidable circumstances.
12. The declaration on curbing the menace of ragging must be given along with the online filled-in application form in prescribed format at the time of admission.
