Candidates must have to register themselves and submit the admission form online to participate in the said admission process otherwise the candidature will be treated as cancelled.**

- Self attested photocopy of SC/ST/OBC (Category-A)/ OBC (Category-B)/EWS/ PwD Certificate (wherever applicable),
- NCL Certificate for OBC (Category-A)/ OBC (Category-B) candidates (wherever applicable),

Domicile Certificate obtained from the West Bengal e-district portal (<https://edistrict.wb.gov.in/PACE>) will also be accepted as the proof of domicile.

The admission fees of **Rs. 13,660/-** (Inclusive Rs. 1500/- as cost of online application fee) **for General/ EWS, OBC (Category-A)/ OBC (Category-B) (Hosteller)** candidates & **Rs. 13,360/-** (Inclusive Rs. 1200/- as cost of online application fee) **for SC, ST, PwD (Hosteller)** has to be deposited on the day of admission **by cash through Bank-challan at Belgachia branch only of Union Bank of India located at University Campus.** [*Service charge and Applicable tax are extra].

The Venue for Physical Reporting and Admission will be at the Office of the Controller of Examinations, WBUAFS, Vivek Bhawan, 68, K. B. Sarani, Belgachia, Kolkata – 700 037, West Bengal (Nearest location- Belgachia Metro Station, Google map location- [Click here to locate](#)).

General Instructions:-

1. All the admission will be provisional. If at any stage it is found that you are otherwise ineligible or you have suppressed any material information or you have submitted false information/ documents, the admission will stand cancelled.
2. **The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an updated NCL certificate on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.**
3. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (Category-A) candidates if unfilled, will be filled up by the OBC (Category-B) candidates and vice versa.

4. **Candidate must have to produce Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b or e-district) issued by the competent authority only as per guidelines of Govt. of West Bengal ([Click here](#) to download the proforma) on the day of the physical reporting and admission failing which the candidate will not be considered for admission.** In case of proforma b or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhaar Card, Passport) of the concerned parent during the stage of document verification where the said ID cards show that the residential address is in West Bengal. **Domicile certificates issued by any elected people's representative such as municipal commissioner, Councilor of Municipal Corporation/ Municipality, Member of three-tier Panchayat system or GTA, MLA or MP are not acceptable.**
5. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof.
6. In case of any dispute, the decision of the admission committee shall be full and final.
7. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056-BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107-BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
8. The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
9. University may cancel or withheld the admission process in unavoidable circumstances.

The selected candidates must have to submit the downloaded online Anti-Ragging affidavit, it is mandatory for every student and his/her parents to submit an anti-ragging affidavit at the time of first registration and there after each year at the time of subsequent registration through two designated websites, namely www.antiragging.in and www.amanmovement.org.
