Applications are invited in the prescribed format from the interested eligible candidates for admission to 2<sup>nd</sup> Professional of B.V.Sc. & A.H. Degree Programme through Migration/ Transfer in the Academic Session: 2024-2025 under the Faculty of Veterinary and Animal Sciences, W.B.U.A.F.S., Mohanpur campus, Nadia, West Bengal through University website (<a href="http://www.wbuafsce.org">http://www.wbuafsce.org</a>). The admission process will be followed as per the MSVE-2016 regulations (clause no.-10) of the Veterinary Council of India, New Delhi.

# Eligibility Criteria for Admission through Migration/Transfer (Academic Session: 2024-2025):

- **1.** Citizenship: The Applicant must be a citizen of India.
- 2. The candidate must obtain a rank in the NEET-UG-2023 conducted by NTA.
- **3.** The candidate must pass First Professional B.V.Sc. & A.H. Examination from a recognized Veterinary College which is included in the first schedule of the Act.
- **4.** The students who have failed in 2<sup>nd</sup> Professional B.V.Sc. & A.H. or expelled by the College/ University will not be eligible for admission.

# Candidates will have to enclose the photocopies of following documents with the application form. Failing which the application will be treated as cancelled:

- Self attested photocopy of Secondary Examination Admit Card/ Birth Certificate as age proof,
- Self attested photocopy of Mark sheet of Higher Secondary (10+2) Examination,
- Self attested photocopy of Mark sheet of 1st Professional B.V.Sc. & A.H. Examination,
- No Objection Certificate (NOC) from the present Institute/ University.
- Self attested photocopy of NEET-UG-2023 Score card.
- Self attested photocopy of Aadhaar Card or any other Govt. ID cum address proof,

### **General Instructions:-**

- 1. Hardcopy of the duly filled-in Application Form along with the aforementioned required documents must be submitted to the <u>Controller of Examinations, WBUAFS, Vivek Bhawan, 68, K. B. Sarani, Belgachia, Kolkata-700 037</u> within <u>13<sup>th</sup> December, 2024</u> either by hand or by post failing which no application will be entertained.
- **2.** The Provisional Merit List will be prepared on the basis of 50% marks of 1st Professional B.V.Sc. A.H. and 50% marks of NEET-UG-2023 examination.
- **3.** The declaration on curbing the menace of ragging must be given along with the online filled-in application form in prescribed format at the time of admission.
- **4.** Only submission of application does not constitute a right for admission and the decision of the University is full and final.
- **5.** Migration/ Transfer on medical reasons should be considered only after recommendation from the Medical Board. Hence, in case of migration/ transfer on medical ground, the Medical Certificate duly issued by the Government Medical Board must be submitted along with the application form.
- **6.** University reserves the right to increase/ decrease the number of seats or cancel the entire admission process without assigning any reason thereof. In case of any dispute, the decision of the University shall be full and final.
