#### **General Instructions:-**

- 1. Fill in the application form online.
- 2. Applicant can make the payment of application fee (Non-refundable) [Rs. 1500/-\* for General, OBC (Category-A), OBC (Category-B), EWS and Rs. 1200/-\* for SC/ST/PwD Categories] by Online Payment (Net-banking/ Debit card/ Credit card/UPI) [\*Service charge and applicable tax are extra].
- 3. The candidates for admission to Ph.D. Programme must have M.V.Sc./ M.F.Sc./ M.Tech. (Dairy Technology/ Dairy Chemistry/ Dairy Microbiology/ Dairy Engineering) from a recognized University with 55% marks in aggregate or 2.75 OG.P.A. in 4.00 point scale or 6.75 O.G.P.A. in 10 point scale following a Bachelor's Degree in Veterinary and Animal Sciences (5 years)/ Dairy Technology (4 years)/ Fishery Sciences (4 years) from a recognized University or National Institute. Submission of PDC/Final Transcript is obligatory with application.
- 4. There is no separate quota for In-service candidates. 'NOC' from the employer of the In-service candidate is obligatory with application.

- 5. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (CATEGORY-A) candidates if unfilled, will be filled up by the OBC (CATEGORY-B) candidates and vice versa.
- 6. The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an <u>updated NCL certificate</u> on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.
- 7. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056-BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107-BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
- 8. The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
- 9. Only submission of online application does not constitute a right for admission and the decision of the admission committee is full and final.
- 10. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
- 11. University may cancel or withheld the admission process in unavoidable circumstances.
- 12. The declaration on curbing the menace of ragging must be given along with the online filled-in application form in prescribed format at the time of admission.
