Diploma in Veterinary Pharmacy (D.V.P.) Course (Academic Session: - 2025-2026)

Online applications are invited in the prescribed format from the interested candidates for admission to D.V.P. Course (2 years) for the academic session: 2025-2026 under the Faculty of Veterinary and Animal Sciences, Mohanpur campus, Nadia through University website (www.wbuafsce.org).

The admission schedule will be as follows:-

Eligibility Criteria-

- 1. Citizenship: The Applicant must be a citizen of India.
- 2. Age- Not less than 17 years and not more than 32 years as on 31st December of the year of admission. There shall be a relaxation of the upper age limit by maximum 3 (three) years for SC/ST/OBC (Category-A)/OBC (Category-B) candidates.
- 3. The candidate must be a domicile of West Bengal.
- 4. The candidate must pass Higher Secondary (10+2) Examination of the West Bengal Council of Higher Secondary Education or its equivalent examination in science stream from any recognized Board/ Council from any institution.
- 5. The candidate must pass the Higher Secondary (10+2) or its equivalent examinations with English, Physics, Chemistry and Biology or Mathematics as compulsory subjects with individual pass marks (in both theory and practical wherever applicable) in all the above four subjects in regular class mode.
- 6. The candidate must obtain at least 45 % marks (40 % in case of candidates belonging to SC, ST, OBC-A, OBC-B, PwD) in above four subjects taken together.
- 7. The selection of students for admission will be done as per merit list without any Entrance Examination. The merit list will be prepared according to the percentage of total marks obtained in the subjects of H.S. or it's equivalent examinations as stated above.
- 8. Students of the Vocational stream or Open schooling are not eligible for the course.

Candidates will have to upload the cleared scanned copies (colour) of their original documents as follows in JPG/JPEG format during online application. Failing to this the candidate will not be considered for admission:

- Admit card of Secondary Examinations / Birth certificate as age proof.
- Mark sheet of Secondary (Class-X) Examinations.
- Mark sheet of Higher Secondary (10+2) Examinations.
- SC/ST/OBC(CATEGORY-A)/OBC(CATEGORY-B)/EWS/PwD Certificate (wherever applicable)
- Latest NCL Certificate for OBC (Category-A)/ OBC (Category-B) candidates (wherever applicable),
- Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b) as per guidelines of Govt. of West Bengal. (Click here to download the Proforma). Domicile Certificate obtained from the West Bengal edistrict portal (https://edistrict.wb.gov.in/PACE) will also be accepted as the proof of domicile.
- Aadhaar Card.

General Instructions:-

- Applicant can make the payment of online application fee (Non-refundable) [Rs. 1500/-* for General/OBC (CATEGORY-A)/OBC (CATEGORY-B)/EWS and Rs. 1200/-* for Reserved Categories (SC/ST/PwD)] by Online Payment (Net-banking/ Debit card/ Credit card/UPI). [*Service charges and applicable taxes, if any are extra].
- 2. Candidate must have to produce Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b or e-district) issued by the competent authority only as per guidelines of Govt. of West Bengal (Click here to download the proforma) along with online application as well as on the day of the physical reporting, counselling and admission failing which the candidate will not be considered for admission. In case of proforma b or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhaar Card, Passport) of the concerned parent during the stage of document verification where the said ID cards show that the residential address is in West Bengal. Domicile certificates issued by any elected people's representative such as municipal commissioner, Councilor of Municipal Corporation/ Municipality, Member of three-tier Panchayat system or GTA, MLA or MP are not acceptable.
- **3.** Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (CATEGORY-A) candidates if unfilled, will be filled up by the OBC (CATEGORY-B) candidates and vice versa.
- 4. The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an <u>updated NCL certificate</u> on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.
- **5.** Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056-BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107-BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
- **6.** The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
- **7.** Only submission of online application does not constitute a right for admission and the decision of the admission committee is full and final.
- **8.** University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
- **9.** University may cancel or withheld the admission process in unavoidable circumstances.
- **10.** The declaration on curbing the menace of ragging must be given along with the online filled-in application form in prescribed format at the time of admission.
