Degree Programme** (5½ years) for the Academic Session: 2025-2026 **in the vacant seats against earlier notification no.- WBUAFS/CE/1136/25, dated-21.11.2025 under the JIS College of Veterinary and Animal Sciences, Mogra, West Bengal (Private Veterinary College affiliated by WBUAFS)** from the Provisional Merit list (3rd Phase) will be held as per following schedule :-

**Candidates will have to bring the following testimonials along with originals for verification at the time of counselling failing which the candidate will not be considered for seat allotment:**

- Printed hardcopy of online filled in Application Form,
- Rank Card of NEET-UG-2025 conducted by NTA,
- Admit Card of NEET-UG-2025 conducted by NTA,
- Self attested photocopy of Secondary Examination Admit Card/ Birth Certificate as age proof,
- Self attested photocopy of Mark sheet of Secondary Examination,
- Self attested photocopy of Mark sheet of Higher Secondary (10+2) Examination,
- Self attested photocopy of SC/ST/OBC-A/ OBC-B/EWS/ PwD Certificate (wherever applicable),
- NCL Certificate for OBC-A/ OBC-B candidates (wherever applicable),
- Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b) as per guidelines of Govt. of West Bengal. ([Click here](#) to download the proforma). Domicile Certificate obtained from the West Bengal e-district portal (<https://edistrict.wb.gov.in/PACE>) will also be accepted as the proof of domicile.

The venue for Counselling cum seat allotment will be at the Examination hall under the Office of the Controller of Examinations, WBUAFS, Vivek Bhawan, 68, K. B. Sarani, Belgachia, Kolkata – 700 037, West Bengal (Nearest location- **Belgachia Metro Station**, [Google map](#) location- [Click here to locate](#)).

Only candidates are eligible to enter into the Counselling venue for seat allotment on presenting the **"Printed hardcopy of Application form"** ([Click here](#) to download). **Entry starts at 01.30 P.M. and ends at 02.00 P.M.** Names of the candidates will be announced during counselling and they must be very careful as it will be announced once only. **Candidates reporting after 02:00 P.M. will not be entertained.**

This is for information to the **Management quota candidates** that the **above admission schedule is also applicable for them.**

**General Instructions:-**

1. The Provisional Merit List (3<sup>rd</sup> Phase) has been made as per NEET-UG-2025 Rank.
2. All the seat allotment will be provisional. If at any stage it is found that you are otherwise ineligible or you have suppressed any material information or you have submitted false information/ documents, the seat allotment will stand cancelled.
3. **Candidate must have to produce Domicile Certificate as per the prescribed format (Proforma a1 or a2 or b or e-district) issued by the competent authority only as per guidelines of Govt. of West Bengal ([Click here](#) to download the proforma) along with online application as well as on the day of the physical reporting, counselling and admission failing which the candidate will not be considered for admission.**  
In case of proforma b or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhaar Card, Passport) of the concerned parent during the stage of document verification where the said ID cards show that the residential address is in West Bengal. **Domicile certificates issued by any elected people's representative such as municipal commissioner, Councilor of Municipal Corporation/ Municipality, Member of three-tier Panchayat system or GTA, MLA or MP are not acceptable.**
4. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (CATEGORY-A) candidates if unfilled, will be filled up by the OBC (CATEGORY-B) candidates and vice versa.
5. **The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an updated NCL certificate on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.**
6. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056-BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107- BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
7. The said 'Counselling cum seat allotment process (3<sup>rd</sup> Phase)' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
8. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
9. University may cancel or withheld the entire admission process in unavoidable circumstances.
10. Participation in counselling does not constitute a right for seat allotment and the decision of the admission committee is full and final.
11. **Selected candidates have to submit an amount of Rs. 10,000.00 as seat acceptance fee on the day of counselling through SBI Collect to appear for physical verification and admission at JISCOVAS, Mogra.**
