General Instructions:-

1. Fill in the application form online.
2. Applicant can make the payment of application fee (Non-refundable) [Rs. 1500/-* for General, OBC (Category-A), OBC (Category-B), EWS and Rs. 1200/-* for SC/ST/PwD Categories] by Online Payment (Net-banking/ Debit card/ Credit card/UPI) [*Service charge and applicable tax are extra].
3. The candidates for admission to Master's Degree Programme must have B.Tech. (Dairy Technology)/ B.F.Sc. from a recognized University with 55% marks in aggregate [50% marks for SC/ST/OBC (CATEGORY-A)/OBC (CATEGORY-B) candidates] in traditional system or with a minimum 6.2 O.G.P.A. [6.0 for SC/ST/OBC (CATEGORY-A)/OBC (CATEGORY-B) candidates] in 10 point system. Submission of PDC/Final Transcript is obligatory with application.
4. There is no separate quota for In-service candidates. 'NOC' from the employer of the In-service candidate is obligatory with application.

1. Seats reserved for SC candidates if unfilled, will be filled up by the ST candidates and vice versa. Likewise, seats reserved for OBC (CATEGORY-A) candidates if unfilled, will be filled up by the OBC (CATEGORY-B) candidates and vice versa.
2. **The OBC (Category-A)/ OBC (Category-B) candidates belonging to the Non-Creamy Layer (NCL) are only eligible for admission as reserved category candidates. OBC (Category-A)/ OBC(Category-B) candidates must produce an updated NCL certificate on the day of physical reporting and admission failing which the candidate will be treated as Unreserved (UR)/ GENERAL. NCL Certificate [for OBC (Category-A)/ OBC(Category-B)] and EWS certificate must be issued in appropriate format on or after 01.04.2025 as per guidelines of Govt. of West Bengal presently in vogue.**
3. Reservation policies will be according to the extant rules of Govt. of WB for admission in reserved seats for SC/ST. The Reservation for OBC (Category-A) and OBC (Category-B) will be followed as per State Government issued Kolkata Gazette Notification No. 917-BCW/MR-33/2025 dated 08.05.2025, Notification Nos. 1056-BCW/MR-33/2025(Pt.I) and 1057-BCW/MR-38/2025 dated 27.05.2025, Notification Nos. 1106-BCW/MR-38/2025 and 1107- BCW/MR-38/2025 dated 03.06.2025 (effective from 10.06.2025).
4. The said 'Admission' shall abide by the final outcome of the litigations pending before the Hon'ble Apex Court of India and the Hon'ble High Court at Calcutta.
5. Only submission of online application does not constitute a right for admission and the decision of the admission committee is full and final.
6. University reserves the right to increase/ decrease the number of seats without assigning any reason thereof. In case of any dispute, the decision of the admission committee shall be full and final.
7. University may cancel or withheld the admission process in unavoidable circumstances.
8. The declaration on curbing the menace of ragging must be given along with the online filled-in application form in prescribed format at the time of admission.
